

### EMT-Basic Refresher

HealthONE EMS, in partnership with Arapahoe Community College, offers the EMT-Basic Refresher course consisting of 48 hours of classroom and practical sessions and a 4-hour State Certification Practical Skills Examination. The course meets National Registry EMT-B Section I renewal requirements and the Colorado State renewal requirements. For Section II requirements please refer to National Registry documents. If you are admitted into the EMT-Basic refresher course, we can make no guarantee of your ability to re-certify through National Registry or the State of Colorado. We will grant a course completion certificate once you have completed all course work successfully. Your eligibility to re-certify must be verified by you with National Registry and the State of Colorado. The scenario based course will consist of scenarios and simulations in simulation labs.

This course is web enhanced. In addition to classroom time some course work will be completed online. Students must have internet access preferably with a high speed connection.
