

HealthONE EMS, in partnership with Arapahoe Community College, offers the IV Approval course. Students certified as EMT-Basics in the State of Colorado are permitted to perform intravenous insertion under medical direction following successful completion of the course. The class includes 24 hours of the theory of fluid therapy and practical training and 8 to 16 hours in-hospital clinical experience. Current Colorado EMT-B and National Registry certificates must be submitted to HealthONE EMS prior to clinical sign up. IV Approval Course Completion Certificate will not be issued until all prerequisites have been submitted.
